Individual Credit Application - CFN Access Card, Bulk Deliveries & Home Heating

Agreement and Terms

The undersigned hereby makes this application for credit to Baird Oil("Creditor"), and in making this application the undersigned agrees to be bound by all of the terms and conditions contained in this Credit Application, any documents referenced in this Credit Application or any supplements. The undersigned agrees that all amounts payable on or before the due date as shown on each invoice will be paid by the said date and if not paid on or before said date, are then to be deemed to be delinquent. Should a credit availability be granted by Creditor, all decisions with respect to the extension or continuation of credit shall be in the sole discretion of Creditor. Creditor may terminate any credit availability and access to fuel at any time within its sole discretion. Upon termination, you agree to immediately surrender all card lock cards issued to you and to immediately pay all outstanding sums owing to Creditor. You are responsible for all purchases by you or any other person using card lock cards issued to you, regardless of whether use by any other person is unauthorized or fraudulent.

You represent that you and any person using the card lock cards delivered to you are aware of the proper use of the card lock system and will use safe practices in compliance with the regulations of the local Fire Code in the handling of the fuels dispensed. You agree to indemnify and hold Creditor harmless from any claims and costs including, but expressly not limited to, those for bodily injury and property damage which may be occasioned by the negligence or misuse of the card lock system by you or any person using the card lock system with card lock cards delivered to you hereunder.

Creditor shall use its best efforts to maintain the card lock system in good working order and condition at its expense: provided, however, Creditor shall not be responsible for any damage or loss which may result from its failure to provide fuel or the failure of the card lock system in any manner whatsoever. You agree that you and any person using the card lock cards delivered to you shall promptly notify Creditor of any malfunctioning of the card lock system of which you or such person is aware.

TERM OF SALE: Purchases made from the 1st -15th are due on the 25th of the same month. Purchases made from the 16th -31st of the month are due the 10th of the following month. It is understood that Creditor may impose a delinquency charge or fee on any amount which becomes delinquent (.875% semimonthly or 1.75% monthly). Additionally, the undersigned agrees to be responsible for all collection costs and attorney's fees in connection with any delinquent amount placed for collection.

THE PERSONS SIGNING THIS APPLICATION CERTIFY THAT ALL THE INFORMATION CONTAINED IN THIS APPLICATION AND ANY ATTACHMENT OR AMENDMENT IS TRUE, CORRECT AND COMPLETE TO THE BEST OF THEIR INFORMATION, KNOWLEDGE AND BELIEF.

The undersigned agrees to provide Creditor with an updated credit application on request as a condition for the continued extension of credit. The undersigned agrees to pay for all purchases of goods or service according to the terms of Creditor. No terms or conditions of purchase orders different from the terms of Creditor will become part of any sales agreement, purchase order, or other document unless specifically approved in writing by Creditor. Payments may be applied against open charges in the discretion of Creditor. On request, the undersigned agrees that the continued solvency of the undersigned is a precondition to any sale made by Creditor. In the event that from time to time Creditor may owe credits, refunds or other monies to the undersigned, such indebtedness shall be deemed to be created from this agreement and creditor shall have the right to recoupment of such credits or refunds within its sole discretion. The undersigned agrees to provide Creditor a statement representing that the undersigned is and remains solvent. If there is any change in your ownership or if substantially all of you assets are sold you will promptly notify Creditor of such sale and Creditor will have a lien on all your assets and a lien on the proceeds of such sale to secure payment of all outstanding sums owing to Creditor.

The undersigned acknowledges and agrees that Creditor may utilize outside credit reporting services to obtain information on the undersigned. In the event that the undersigned is/are individual(s), the signing of this agreement shall constitute authorization to Creditor to utilize consumer credit reporting agencies to provide reports on said individual(s) in order to permit Creditor to appropriately evaluate the extension of any business credit. Additionally, should any individual(s) guaranty the debt of the undersigned, said individual(s) shall be provided with a copy of this application and upon the signing of said guaranty, shall consent to Creditor's use of consumer credit reporting agencies report to assist in the evaluation of the credit of said guarantor(s).
